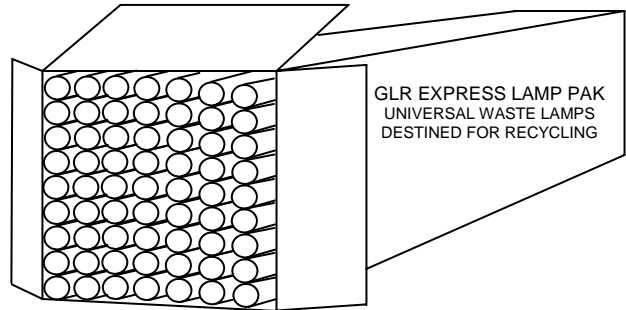

1.) Fill shipping container completely full of discarded INTACT lamps for recycling.

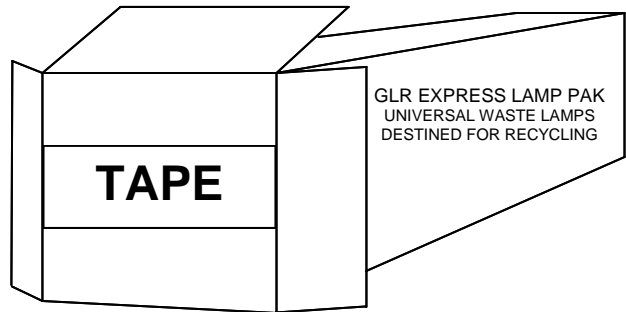


DO NOT TAPE LAMPS TOGETHER.
KEEP LAMPS & BOX DRY.

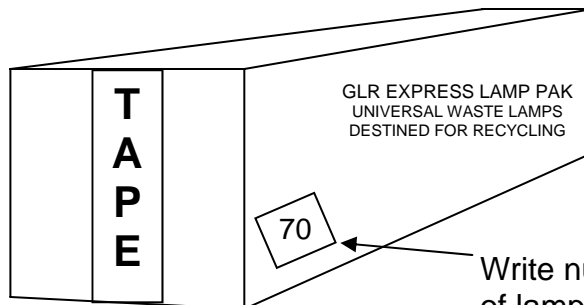
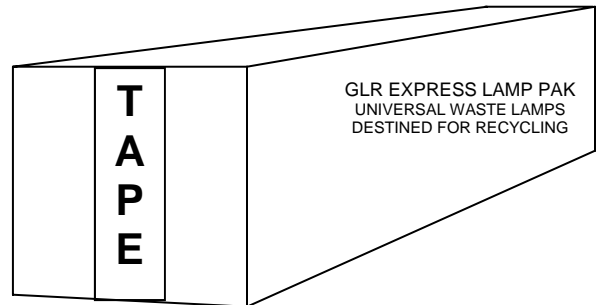
2.) Important! Seal container Securely.
